Index Exchange does not charge the beneficiary any fee for this service

Key Terms & Conditions

- Index Exchange is at liberty to receive Incoming Remittances as per the details submitted by you (as the beneficiary of funds), and the Exchange accepts no responsibility for any loss, delay, error, omission, or mutilation in the transmission of the message or its misinterpretation when received
- The Exchange shall pay the amount of transfers received in favor of the customer (you as beneficiary)
- The Exchange shall have the right to reject the payment if the beneficiary details given by the Remitter do not match the details provided by the recipient of funds
- Payment to the recipient will be affected instantly after verification of ID
- Index Exchange is authorized to disclose any information to:
 - (i) Any third party as it may deem fit in its absolute discretion, including but not limited to its subsidiaries, branches, agents, correspondents, agencies, or representative offices,
 - (ii) Any person authorized by the Exchange to do so
 - (iii) Any other bank or financial institution
 - (iv) Any service provider or professional advisors and for them to disclose the information to third parties or parties
 - (v) Any government authority, within the United Arab Emirates or outside and
 - (vi) Any other person to whom it considers in its interest to make such disclosure
